

# Terms of Use

---

Effective Date: April 27, 2024

## Acceptance

---

By using the DialApp App, you agree to be bound by these Terms of Use. If you do not agree with any part of the Terms, you must not use the App.

## Changes to the Terms

---

We may amend these Terms from time to time. If we make material changes, we will notify you either via email or by posting a notice in the App. Your continued use of the App after such changes constitutes your acceptance of the revised Terms.

## Eligibility

---

You must be at least 18 years of age to use the App. If you are between the ages of 13 and 17, you may use the App only under the supervision of a parent or guardian, who must review these Terms with you.

## App Use

---

The App allows you to make outgoing calls to local numbers. The App is intended for personal, non-commercial use only. You agree not to use the App for any illegal or unauthorized purpose, including but not limited to:

- Making harassing or threatening calls
- Engaging in fraudulent activities
- Using the App for telemarketing or unsolicited communications

## User Responsibilities

---

You are responsible for maintaining the confidentiality of your account information, including any assigned phone number. You are liable for all activities conducted through your account and agree to notify us immediately of any unauthorized use.

## Terms of Service for Minute Packages and Pricing

---

- Purchase of Minute Packages Users may purchase minute packages according to the rates displayed in the "GET TIME" section of the app. The cost of each package and available rates are shown in this section and may change without prior notice.
- Expiration of Minute Packages Each purchased minute package has a set expiration period provided at the time of purchase. Unused minutes will expire and become unavailable after this period.
- Extension and Rollover of Minutes If a new minute package is purchased before the current package's expiration date, the expiration date will be extended, and any remaining minutes from the current package will be added to the new package balance.
- Refunds and Unused Minutes Unused minutes are non-refundable and are available only within the active period of the purchased package. Upon expiration, any remaining minutes are forfeited and cannot be accessed.
- Changes in Rates and Expiration Terms DialApp reserves the right to modify the prices and terms of minute packages, including expiration periods, at any time. Users will be notified of such changes via email or app notifications.
- Minute Packages Usage Restriction Minute packages are intended for personal, non-commercial use only. Users are prohibited from using minute packages for telemarketing, automated dialing, mass messaging, or any activities that violate the app's usage policy.
- Acceptance of Terms and Activation of Package By purchasing a minute package, users agree to these terms as confirmed by the transaction completion. The minute package is activated automatically upon successful payment.

## Indemnification

You agree to indemnify and hold harmless DialApp and its affiliates from any claims, losses, damages, or liabilities, including legal fees, arising from your use of the App in violation of these Terms.
